PARTICIPANT'S VOLUNTARY RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

I agree and acknowledge that:

1. Crystal Springs Campground, LLC, collects tube, kayak, and life vest rental fees on behalf of CSC Rentals, LLC, and that the tubes are owned and leased by CSC Rentals, LLC. I acknowledge that Crystal Springs Campground, LLC is not the owner, manufacturer or dealer of the tubes or rental equipment and has not made and does not make any representation or warranty, express or implied, with respect to the condition, quality, durability or suitability of the rental equipment.
2. **I, on behalf of myself and/or as the parent or legal guardian of the minor child (children) identified on this document, VOLUNTARILY ACCEPT AND ASSUME ALL RISKS, BOTH KNOWN AND UNKNOWN, OF INJURY OR DEATH OR PROPERTY DAMAGE that might be associated in any way with or result from use of the rental equipment owned or transportation provided CSC Rental, LLC. I understand there are risks associated with river tubing and recreation which include, but are not limited to, such things as changing weather conditions, natural or man-made features that may exist along the river channel and natural or man-made features within the river channel. I understand some features may not be visible and floatation devices may capsize, be punctured and/or be difficult to maneuver. I acknowledge that it is my sole responsibility to evaluate carefully the risks inherent in river tubing and recreation and that I have fully considered those risks, including, without limitation, dangers posed by willful or negligent conduct of myself and/or others. I further understand that infants, small children, individuals who cannot swim and anyone suffering from serious medical conditions should not float the river or participate in water recreation and that personal floatation devices should be worn by all persons while on the water. I understand that, per Idaho State Code and I.D.A.P.A. Rule, all persons 14 years of age and younger "must" wear a U.S. Coast Guard-approved personal floatation device (PFD) while in or upon a boat or raft. I AGREE ON BEHALF OF MYSELF, MY MINOR CHILD (CHILDREN), MY AND/OR THEIR HEIRS, REPRESENTATIVES, EXECUTORS, ADMINISTRATORS AND ASSIGNS TO INDEMNIFY, DEFEND, AND HOLD CRYSTAL SPRINGS CAMPGROUND, LLC, ITS OFFICERS, AGENTS, AND EMPLOYEES HARMLESS FROM AND AGAINST ANY AND ALL LIABILITY OR EXPENSE RELATED TO INJURY OR DEATH TO MYSELF OR MY MINOR CHILD (CHILDREN), OR TO OUR PROPERTY, OR TO ANY PERSON OR PARTICIPANT OR PROPERTY INCLUDING REASONABLE ATTORNEY'S FEES, IN INSTITUTING OR DEFENDING ANY ACTION OR PROCEEDING ARISING FROM MY OR MY CHILD'S (CHILDREN'S) USE OF COUNTRY STORE'S RENTAL TUBES OR TRANSPORTATION SERVICES, INCLUDING, BUT NOT LIMITED TO, CLAIMS FOR NEGLIGENCE, BREACH OF WARRANTY, CONTRACT, CLAIM, OR ANY OTHER LEGAL THEORY.**
